1. The maximum number of children shall be as follows:

Ages 1.5-2: 18 Children

Ages 2-3: 22 Children

2. The Gan will operate from 1<sup>st</sup> September 2026 until 5<sup>th</sup> August 2027 (Hereinafter: "Agreement period").

3. The Gan will operate from Sunday-Thursday between the hours of 07:30-15:45.

On Fridays the Gan will operate between the hours of 07:30-12:00.

4. Fee is 4,500 NIS for a long day (until 15:45, including lunch).

NOTE: In the event the government changes the rate of VAT, the fee will be adjusted accordingly.

5. Payment is due on the first of each month from September 2026 until and including August 2027.

Checks are to be made payable to 'Gan Tammy'.

6. All checks should be given in by Pesach 2026.

7. Payment is due even in absence of the child due to illness/holiday or any other reason.

8. MEDICAL DECLARATION: Parents declare their child/children to be healthy with nothing to prevent or limit them from participating in activities. If a medical condition arises, the parent/s is/are obligated to present a note from a Doctor allowing them to be in Gan.

9. In the event of cancellation:

\* Cancellation fee up to August 2026 will obligate the parents to pay for September 2026.

In the event an acceptable replacement is found, the parents will be exempt from paying September 2026.

\* Cancellation between August to December 2026 will obligate the parents to pay until the end of the month and for one additional month. In the event an acceptable replacement is found, the parents will be exempt

from paying the additional month.

\* Cancellation after January 2027 will obligate parents to pay until August 2027. In the event that an acceptable replacement is found, the parents will pay until the end of the month and one further additional month.

\* Cancellation notices shall be given in writing.

\* The Gan reserves the right to eject a child for medical reasons, disciplinary problems, or any other reason.

### **Payment Schedule for Government-Ordered Closure**

Parties agree that in the case of a closure of Gan Tammy due to an act of G-d (this includes flood, fire, pandemic, war or any other government-ordered closure) the parents, on 1<sup>st</sup> of the immediate calendar month that follows the commencement of the closure, will pay a reduced fee **only** if a government assistance 'chalat' system is in place: 30% reduction if closure occurs on or after the 15<sup>th</sup> of that calendar month, or 50% reduction where the closure occurs prior to the 15<sup>th</sup> of that month. With the end of the act of G-d, Gan Tammy shall give maximum notice possible in the circumstances of the re-opening of gan, whereupon full payment shall resume.

The above addresses the payment obligations of parents on the first month immediately following a closure of the gan in the event of a government shutdown. In the case of a prolonged closure, on the subsequent months parents will pay a reduced cost of 2000NIS per month in the payment periods after the month immediately following a closure.

In the case of an immediate but limited time period shutdown (for example someone in the gan testing positive for Covid-19 if that regulation is still in place) the parents will pay full fees as per the normal payment schedule.

## **Gan Tammy Sickness Policies**

The Gan Tammy staff try to maintain a healthy environment as much as possible, with that in mind it is also important to understand that if this is the first gan exposure that your child has had away from your home, they will be more susceptible to viruses and general illness.

### **Temperature &/or diarrhea or vomiting**

No medicine is kept or administered in the gan, so if your child has a temperature or an episode of diarrhea or vomiting, you will be called and asked to pick up him or her.

- A child can only return to the gan after a FULL 24 hour period of normal temperature.
- A child may return to gan no sooner than 24 hours after the last episode of diarrhea or vomiting.

### **Eye infections**

These can be highly contagious, especially with young children.

If your child has pink eye, weeping or puss coming out of their eyes they cannot come to gan, and if seen during the morning, you will be asked to collect your child and take to the doctor.

After your child has been on antibiotic drops for a minimum of 24 hrs they can return or with a doctor's note.

### **Sickness where antibiotics are needed.**

You may return to the gan 24 hours after antibiotics are taken, or longer depending on doctors instructions. Following a highly contagious infection, for example Hand, Foot and Mouth; Slap Cheek, Impetigo or Chicken Pox, a doctors note will be required before the child can return to gan.

### **Lice**

Please notify the staff if your child has lice, so we can inform all the parents.

If your child is found to have lice during the day, you will be notified upon pick up and required to treat your child's hair before returning.

There will be a notice posted on the information's boards and parents will be required to keep checking their child's hair to prevent the spreading of lice.

### **State Health Regulations**

The gan will adhere strictly to government health regulations and restrictions (e.g. Covid 19) if and when they are mandated. These may change during the course of the year.

If the change is permanent - the kindergarten teacher must be notified. If there are child custody arrangements between the parents, the kindergarten teacher must be notified.

## **Holidays**

The gan will be closed on erev chagim and chagim.

The gan will also be closed on chol hamoed Pesach and Sukkot and Isru Chag Pesach.

In addition, the gan will be closed for 3 days during Chanukah, 3 days over Purim (Taanit Esther, Purim and Shushan Purim) and for the 3 days before Pesach.

In the month of July gan will be closed on the last three Fridays in July 2027

**Please note:**

Snow days: The gan will not open if the Irya decides to close the city's schools/kindergartens for snow or any other reason.

Gan will finish at 3.30pm on the days that we are open on Chanukah.

Gan will be closed on the day of the Jerusalem Marathon.

In general, we follow the Misrad HaChinuch calendar with the differences outlined above. A more detailed calendar will be sent closer to the beginning of the year.
